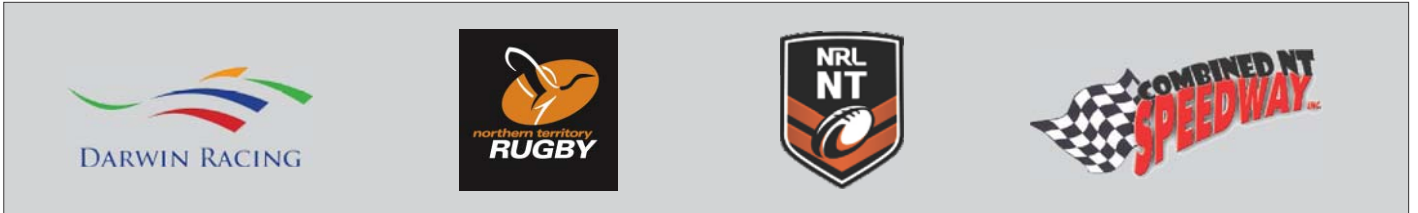

Terms and Conditions of Membership & Members Patronage of the Club.

The Palmerston Sports Club is a Licensed Club with entry restricted to Members, Members Guests and Bona Fide Visitors.

The Classification House membership of the Palmerston Sports Club Inc. entitles the member to utilise the Clubs facilities, including the members only Bottleshop. Membership cards MUST be shown to obtain service from the Bottleshop.

House members are NOT entitled to voice or vote in the affairs of the Club.

Privacy

The Palmerston Sports Club is subject to the provisions of the Privacy Act 1988. The personal information provided by you on this form/application and attached documents will be used to process your membership application. Failure to provide all if the requested information may result in your application being rejected. You have a right to access and correct any of your personal information that the Club holds about you.

Members

Are required to swipe their card upon entry and to have their membership card upon at all times when visiting the Club. The Club reserves the right for employees to demand sighting of the cards upon entry to the Clubs licensed facilities and at any time whilst upon the Clubs licensed facilities. Membership cards are not transferable and are for the use only of the member to whom the card was issued. The Club reserves the right to suspend and or cancel membership should cards be used in any manner contrary to their intended use. Lost/stolen cards should be reported to the Club immediately. A replacement card will be issued at a cost of \$5.00

Members Guests

Members are entitled to sign in up to six (6) Guests at any one time. The same guest may only be signed in a maximum of six times in any 12 month period. Guests signed in by a member must remain in the company of the member whilst on the Club premises.

Dress Standards

The established and displayed dress standards/regulations will be enforced by Club staff. Management's decision shall be final in all matters relating to dress standards.

Code of Conduct

Club Patrons are required to behave in a manner conducive to the enjoyment of our facilities by all patrons. Obscene and or offensive language or clothing will not be tolerated, whilst quarrelsome, unruly, violent, inappropriate behaviour will not be tolerated and may result in the expulsion of the patron.

Management's decision shall be final in all matters relating to behavior standards.

Responsible Service Of Alcohol

The Club is committed to the principals of responsible service of alcohol, and will ensure that all persons in this Club adhere to these principals at all times. Management will support the staff in the enforcement of refusal of service to intoxicated patrons.

Responsible Provision of Gambling

The Palmerston Sports Club will conduct all aspects of its facility in a professional and responsible manner in keeping with the spirit of the NT Responsible Code of Practice and will abide by all elements of the Gaming Policy & Regulations whilst upholding its commitment to provide a responsible gaming environment.
